

## **Official Sweepstakes Rules and Regulations**

No purchase or payment of any kind is necessary to enter, win, or claim a prize.

The Membership Referral (“Contest”) is sponsored by Landings Credit Union (“Sponsor”). This event is governed by these official rules (“Official Rules”) and is subject to all applicable laws and regulations. Void where prohibited by law. By participating, you agree to abide by these Official Rules, including all eligibility requirements, and understanding that the results, as determined by Landings Credit Union, are final in all respects.

### **1. CONTEST PERIOD:**

The Contest will begin on July 1, 2024 and ends on December 31, 2024.

### **2. ELIGIBILITY:**

The drawing is open to legal residents of the fifty United States who are eligible members of Landings Credit Union.

### **3. HOW TO PARTICIPATE:**

Five (5) winners of a \$100 cash prize will be selected monthly (July - December 2024) along with one (1) winner of the \$500 Grand Prize at the end of the contest period. You may enter to win by referring an eligible family member or friend to Landings Credit Union who opens and funds a Share Account. All entrants participating during the Contest Period will be entered for a chance to win the monthly \$100 cash prize and the \$500 Grand Prize. No purchase is necessary. You may also enter by mailing a 3 x 5 card to: Landings Member Referral, 2800 S. Mill Avenue, Tempe, AZ 85282. The winner will be drawn at random.

### **4. DRAW DATE:**

One (1) random draw will be held 7 days after the end of each month during the Contest for each of the six months. One (1) random draw will be held 7 days after the end of the Contest Period for the Grand Prize. Eligible entrants will be randomly drawn from among the eligible entries. The odds of being selected depend on the number of eligible entries received.

### **5. PRIZE AWARDING:**

If you are selected as a potential winner of the \$100 monthly drawing or the \$500 Grand Prize, your cash prize will be deposited into your Landings Credit Union savings account upon verification and final approval.

### **6. CONTEST GENERAL RULES:**

By entering the Contest, Entrants agree to abide by these Contest Rules and the decisions of the sponsor, which are final. All Entrants release and forever discharge the Sponsor, its advertising and promotional agencies, and their respective affiliated companies, and all their respective officers, directors, employees and agents from all claims, demands, damages, actions and causes of action arising or to arise by reason of his/her participation in the Contest and/or the administration of the Contest, including, without limitation, the selection and awarding
