

Official Sweepstakes Rules and Regulations

No purchase or payment of any kind is necessary to enter, win, or claim a prize.

The \$1,000 Membership Drive (“Contest”) is sponsored by Landings Credit Union (“Sponsor”). This event is governed by these official rules (“Official Rules”) and is subject to all applicable laws and regulations. Void where prohibited by law. By participating, you agree to abide by these Official Rules, including all eligibility requirements, and understanding that the results, as determined by Landings Credit Union, are final in all respects.

1. CONTEST PERIOD:

The Contest will begin on April 1, 2022 and ends on May 31, 2022. A winner will be selected 7 days from the close of the Contest period.

2. ELIGIBILITY:

The drawing is open to legal residents the fifty United States, who are 18 years of age and older and eligible members of Landings Credit Union.

3. HOW TO PARTICIPATE:

One winner of a \$1,000 cash prize will be selected. You may enter to win by opening a new membership with Landings Credit Union along with a checking account set up with direct deposit. All entrants participating during the Contest Period will be entered for a chance to win a \$1,000 cash prize. No purchase is necessary. You may also enter by mailing a 3 x 5 card to: Landings Membership Drive, 2800 S. Mill Avenue, Tempe, AZ 85282. The winner will be drawn at random.

4. DRAW DATE:

One (1) random draw will be held 7 days after the close of the Contest Period. Eligible entrants will be randomly drawn from among the eligible entries. The odds of being selected depend on the number of eligible entries received.

5. PRIZE AWARDING:

If you are selected as a potential winner, your \$1,000 cash prize will be deposited into your Landings Credit Union savings account upon verification and final approval. Attempts will be made to contact the Selected Entrant at the telephone number and/or email address listed on the entry for a period of three (3) business days following the Draw Date. If the Selected Entrant cannot be contacted within the allotted time, the Sponsor reserves the right to void that entry and select another eligible Entrant for the Prize.

6. CONTEST GENERAL RULES:

By entering the Contest, Entrants agree to abide by these Contest Rules and the

decisions of the sponsor, which are final. All Entrants release and forever discharge the Sponsor, its advertising and promotional agencies, and their respective affiliated companies, and all their respective officers, directors, employees and agents from all claims, demands, damages, actions and causes of action arising or to arise by reason of his/her participation in the Contest and/or the administration of the Contest, including, without limitation, the selection and awarding of the Prize.
